## CIRCULAR

It has been decided to continue the benefit of concessional Electricity to the officers and employees of MPSEB finally transferred to MPPTCL and MD/ Director (Technical), MPPTCL for the financial year 2012-13.

This facility shall be admissible for only one domestic connection, to an employee in his name irrespective of the fact whether he may be residing either in Board's quarter or his own house or in a house taken on rent by him/her.

The facility may be withdrawn if any irregularity is reported/ established against the employee.

To avail the facility, the eligible employees/ officers will fill up the enclosed format (in two copies) within 15 days from the date of issue of this order and get it forwarded by his controlling officer. The employee will submit one copy of the filled in format at the Consumer Service Centre/Distribution Centre in jurisdiction of which, he wants to avail the facility. The second copy of the filled in format will be retained by the controlling office.

The controlling office will compile the relevant details given in the format in the excel sheet in respect of all employees under it and e-mail it to the O/o Chief Engineer(Corporate Affairs), MPPTCL in the e-mail address [consultancympptcl@yahoo.com](mailto:consultancympptcl@yahoo.com) within one month from the date of issue of this order.

The Discoms will issue the compiled statement of the rebate availed by the employees of MPPTCL, under their jurisdiction in excel format in soft copy with employee number tagged, on the monthly basis.

The bill so raised will be verified by the O/o C.E. (Corporate Affairs) MPPTCL. The Discom wise JV/ Debit slip for the passed amount will then be sent to the Chief Financial Officer, M.P.P.T.C.L. for adjustment from the transmission or other charges payable by the respective Discom.


