## ORDER

The erstwhile MPSEB, in order to mitigate the hardship caused to the spouse of a deceased employee, had introduced Annuity Scheme for the employees while in service, for initial period of 2 years vide order No. 01-05/VI/765 dated 30.01.1989. The scheme was run with the assistance of LIC of India, Jabalpur and later on, it was extended from time to time upto 31.12.1992. Subsequently, it was decided vide the erstwhile MPSEB's order No. 02-07/GIS/ Annuity /6251 dated 16.03.1993 to run the Scheme by the Board itself w.e.f. 01.01.1993 and powers were delegated to various authorities for sanction of the Annuity to employees/officers.

On dissolution of MPSEB, the work of annuity in respect of MPPTCL and other successor companies is being looked after by the M.P. Power Transmission Co. Ltd. Therefore, in line with the erstwhile MPSEB's aforementioned circular dated 16.03.1993 as adopted by MPPTCL vide circular No. AS/MPPTCL/1735 dated 25.08.05 read with order No. AS/MPPTCL/2929 dated 10.10.2012, the following powers are hereby delegated for sanction of Annuity in respect of Class I to IV personnel::-
