Sub:- Disclosure of Annual Confidential Report in respect of Account Officers and Section Officers of Finance and Account wing.

It has been provisioned in this office order No.AS/MPPTCL/E-I/517 Dated 07.02.2018 that, "The MP Public Service (Promotion) Rule 2002, as amended from time to time and adopted by the company vide order No 1351 dt 05.06.2012 read with No 165 Dt 13.01.2016, for the cadre of JE to AE and AE to EE, shall be applicable to the officers of equivalent cadre of the Finance and Account wing." Accordingly, the Account Officer & equivalent and Section Officer of Finance and Account wing, shall henceforth be covered under rule 4(2) of the MP Public Service (Promotion) Rule 2002, to pursue their promotion/ Higher Pay Scale related issues.

After being covered under rule 4(2) of the MP Public Service (Promotion) Rule 2002, and consequent upon enforcing the above provisions, read with this office order No.AS/MPPTCL/EE-II/613 Dt 16.02.2016 and circular No.AS/MPPTCL/EE-II/2655 Dt. 02.07.2016, the Annual Confidential Reports in respect of Account Officer & equivalent and Section Officer of Finance and Account wing, shall henceforth be disclosed formally in line with the provisions as made in order No.AS/MPPTCL/EE-II/613 Dt 16.02.2016. They shall also be allowed to represent against the gradings assigned in such ACRs in the manner as prescribed in the prevailing orders/circulars for which Annual Confidential Reports from year 2012-13 to 2016-17 shall be disclosed to the concerned officers/employees only on submission of a written request from such officer/employee to this effect within 1 month from the date of this order. Rest of the terms and conditions shall remain the same as stipulated in order No.AS/MPPTCL/EE-II/613 Dt 16.02.2016.

Accordingly, all orders/circulars as prevailed in the subject matter, shall stand modify to accommodate above proviso, which will be applicable with effect from year 2017-18.
