

- 6 For the cleaning of grass, from the yard mixture of weed killer chemical should be spread to retard re-growing of grass, shrubs and uses in the warded yard of EHV S/S.
7. The payment shall be released by Regional Account Officer MPPTCL Indore with in 45days after receipt of the bill in triplicate through AE 132KV S/S MPPTCL Unhel or in turn as per queue basis which ever is later. MPPTCL shall not be liable for any interest.
8. In case of any dispute the decision of Superintending Engineer (T&C). MPPTCL Nagda will be final and binding.
9. The GST/ tin No/ Income Tax/ Pan No. should be mentioned on quotation.
