
Terms and Conditions

01. Our enquiry No. and due date must be clearly mentioned on the top and at the right hand side on the envelop as well as your quotation.
02. **Price Bid should be in separate envelop and related documents as like. GST Registration, Pan No., Copy of A-class electrical contractor certificate etc. including EMD also be in separate envelop.**
03. Since the work is to be carried out in the switch yard, the contractor should possess "A" class Govt Electrical Contractor certificate and the photocopy of the same is to be enclosed with quotation.
04. The quotation should be clear and visible as per our requirement/specification. Any overwriting or cutting should be initialed by else same shall be rejected.
05. The under signed reserve the right not to accept the lowest or any quotation without assigning any reason what so ever.
06. The payment shall be released by Regional Account Officer MPPTCL Indore with in 45days after receipt of the bill in triplicate through AE 220KV S/S MPPTCL Nagda or in turn as per queue basis which ever is later. MPPTCL shall not be liable for any interest.
07. **Earnest Money:-** You shall have to deposit Earnest Money of **Rs.2000/-** (Two thousand only) in the form of Demand draft payable to Regional Accounts Officer, MPPTCL, Indore. The EMD of unsuccessful tenderers shall be returned after deciding the contract & EMD of successful tenderer would be converted as Security deposit and this amount will be refunded on successful completion of the contract..

08. **Security Deposit:-** you have to deposit 10% of the value of contract towards the security deposit. The S D will be returned after successful completion of the contract and after obtaining certificate from the AE. 220KV S/S Nagda that there is no liability/ No dues on the part of contractor.
09. **Agreement:-** An agreement has to be executed by you on non judicial stamp paper @0.25% of the contract value subjected to the minimum of **Rs.500/-** & maximum of **Rs. 25000/-** only duly affixed with revenue stamp worth Rs. 01/- in the prescribed proforma. The cost of non-judicial stamp paper will be borne by you.
10. In case of any dispute the decision of Superintending Engineer (T&C). MPPTCL Nagda will be final and binding.
11. The GST/ tin No/ Income Tax/ Pan No. should be mentioned on quotation.
12. **Goods and Services Tax (GST):-**As per provision of GST you are requested to pay applicable Tax on the activity covered in this enquiry/contract to the concerned office of Govt. Of India The responsibility for timely payment of above stationary levy and compliance of formalities in this regard shell be your. And a copy of GST registration may also be enclosed with registration other wise the quotation will be canceled.
13. The work shall be carried out in yard hence obeying all safety rules and regulation is necessary to avoid any possibility of accident. However if any accident takes place the contractor shall be fully responsible and MPPTCL will not accept any type liability.
14. Dust and Rust from the surface of structure has to be cleaned thoroughly by wire brush /sand paper as per suitability.
15. First coat of red oxide paint has to be provided and Second coat of Aluminum paint should be applied after curing of first coat of red oxide.
16. All the T&P and safety appliances required to complete the job shall be arranged by the contractor.
17. For any loss and damage of man, material and T&P the contractor shall be wholly responsible and MPPTCL shall not bear any responsibility.
18. The insurance of (W.C.A.) working personal should be arranged by the contractor. In case of any accident MPPTCL not bear any responsibility and liability all the compensation is to be arranged by the contractor.
19. The contractor shall provide the list of the persons to A.E. 220KV S/S Nagda, So that the entry of unauthorized person shall be avoided.
20. Quantity may be vary as per requirement.
