Please quote your lowest rates for painting of following Power Transformer at  
220 KV S/S MPPTCL Betul ( District : Betul ). The details of work are as given under :-

**Scope of work:-**

1. Cleaning of complete Transformer unit, namely Main tank, Radiators, Main & OLTC conservators, Thermosyphon tank, Cooling fans, Fan stand, FCC box, OLTC DM, FCC Box. and all other accessories mounted on transformer from Oil, Sludge, Grease, Dust & Rust etc. by detergent, soap, water and by scrubbing if required. All material & T&P required for this purpose is to be arranged by you.
2. Spray painting of Transformer by Light Grey color paint, Make : ASIAN Smoke / Light Grey Epoxy Paint No.IS-631 or Equivalent reputed make if approved from Officer In-charge. Bushing Top Rain cover / guard is to be painted with RED, YELLOW, BLUE & GREEN COLOR according to their phases. All the Valves must be painted with GOLDEN / BLACK COLOR of same specification.
3. Transformer rails are to be painted with black color paint.
4. Suitable touching by Red Oxide paint to be done at the rusted points on transformer before spray painting of transformer by Light Grey paint.
5. Painting work is must be carried out by Spray Machine. Painting with brush by hand is not allowed.
6. All work is to be carried out as per advice / supervision of S/S in charge & availability of shutdown on the Transformer.

7. All material like Paint , Thinner , Spray machine, Brush and other T&P required for work are to be arranged and transported you at your cost.
8. The painting work is to be carried out as per original thickness of paint on Transformer.

Your offer should reach on or before **Dated 22-09-2018 Upto 15:00 Hrs.** The quotations shall be opened on the same day at 16:00 Hrs. In case the date of opening of quotation is declared as holiday by the competent authority, the quotations shall be opened on next working day at the same place and time.

### **Terms & conditions :-**

1. The rates quoted must be inclusive of material cost, labour & T&P charges, all Taxes ( Except GST ), surcharges & other levies applicable as per law.
2. The quotation should be completed in all respect with relevant technical specification.
3. The required mandatory documents as submitted along with the Quotation are GST registration , PAN card , Electrical contractor License , EPF registration , ESIC registration & latest order copy of such type of Transformer painting work as experience certificate etc. If contractor / firm fails to submit these documents then their candidature for further process of bidding will be rejected.
4. An earnest money of Rs.1000/- in the form of Demand Draft in favor of **R.A.O. MPPTCL Bhopal** payable at Bhopal is to be enclosed for faithful performance of work. In absence of Earnest money the tender / quotation submitted by contractor will not consider for further process of bidding.
5. Our enquiry No. & date must be clearly mentioned on the top of right hand side of the envelope as well as in your quotation.
6. The quotation should be written in figure & words.
7. The quotation should be typed or written in ink only & it should be clear & legible.
8. Any overwriting or cutting of rates & terms & conditions should be initialed by you else the same shall be rejected.
9. Your rates should be according to our specification only. No alternative offer should be mentioned. The offer contrary to our specification will not be considered.
10. After successful bidding process the lowest bidder will have to execute an agreement of Rs. 500/- within 7 days of order to be placed on him.
11. Work should be completed within 10 days from the date of handing over of site otherwise penalty @ 0.5 % per week or part thereof subject to max. 10 % of order amount shall be imposed for delay of work. However the extension of completion period shall be considered only if found necessary due to force major & climatic conditions beyond human control.
12. In the case of work found unsatisfactory it will be responsibility of the contractor to made it good according to our specification / satisfaction, free of cost.

13. Accident / EPF liability of Labour / Persons engaged for execution of work :-

The work place of 220 KV Sub Station Betul is live and charged area. It will be your responsibility to arrange necessary insurance cover as per law / workmen's compensation act, for the persons engaged by you for carrying out the work if required as per rule. The contractor will be fully responsible for accident and EPF liabilities of labour / staff / persons engaged by him for execution of work.

14. You have to arrange all men & material, T&P required for execution of work.
15. Our payment terms :- Payment will be release after completion of work in 30 Days period from the date of submission of bill duly supported by work completion certificate from concerned officer in charge and other relevant documents.
16. No advance payment shall be made in any case.
17. No any interest shall be payable by us in the case of delay in payment.
18. Income tax if any as per rule shall be deducted from your bill.
19. Any other taxes, surcharge, cess etc. levied on the work entrusted to you as per law will be your responsibility and The Company will not be responsible for any consequences in this regard.
20. Any loss to the **Company's** property during the execution of work will be your responsibility & you will have to bear any expenditure incurred towards the same.
21. The validity of rates must not be less than 60 days ( Sixty Days ). Therefore contractor has to mentioned the validity period of their rates. In absence of this , it will assumed that rates are valid up-to 60 days.
22. The undersigned reserves the right to accept or reject any or all offer(s) without assigning any reason thereof. The decision of this office shall be final and binding. No correspondence in this regard shall be accepted.
23. Receipt of your offer to this office within due date and time noted above dully completed in all respect as per terms and conditions mentioned above shall mean that you have carefully noted all the terms and conditions of this enquiry and have accepted in all respect. You need not require to submit your offer if you do not accept any or all of above mentioned terms and conditions.
24. In case of any dispute, the matter will be settled down in the court situated at Itarsi under Hoshangabad district only.
