QUALIFYING REQUIREMENTS: (i) The bidder should have Valid 'A' class electrical contractor's license issued by Govt. of M.P.; EPF Code No., GST No. in the name of Firm./Proprietor.

- (ii) Experience Criteria: The bidder should have successful experience of 50% value of similar work completed including piecemeal works in the past at same or higher or just below voltage leve1 for the proposed erection work in any EHV substation OR. The bidder may be Degree /Diploma engineers having minimum 5 years successful experience of similar works executed under him while in serf ice in Govt./Quasi. Govt. P.S.U. organization. OR Bidders having no past experience in their own name may also participate subject to condition that they will engage an engineer having educational qualification of Degree in Engineering in their respective branch with at least 2 years experience or Diploma in Engineering in the respective branch with 5 years experience in the respective field of MPSEB/,MPPTCL or Govt./Public undertaking/ Reputed Limited Co., However, such bidder should have all other qualifying criteria such as EPF registration No., GST No., Pan etc. as required for experienced bidder.
- (iii) **Financial Criteria**: No financial criteria is required to be fulfilled by the bidder, however the bidder shall be financially sound to finance the required sources for successful execution of the work.
- (iv)The company reserved the right to ignore such offers having inadequate financial capacity or large unexecuted past contracts or where unjustified and substantial delay has already occurred in execution of past contract.
- (v) While deciding award of contract against ant tender apart from the prices quoted and compliance to terms and conditions of the tender specification, MPPTCL, will also take into account such factors as performance against earlier contracts in terms of quality of works done and adherence to prescribed time schedules, Offers of such contractors who have poor record of performance in earlier contracts are liable to be rejected.
