If the tender form is downloaded from the website, payment of Rs 560/- as the cost of the document must be compulsorily deposited by the firm/tenderer, with the bid. It is obligatory for the bidders to purchase tender document or tender document cost is to be submitted along with tender form to be kept in first Envelope with EMD (in case if tender document is downloaded) otherwise it will be liable to be rejected.

- (3). The tenderer shall necessarily have past experience of providing & fixing of office furniture. In absence of above requirement, the tenders shall not be accepted.
- (4). The tenderer should be having GST registration no. as per the provision of GST act along with PAN No, TIN No & all other valid & legal registrations as per rules.
- (5). The tenderer shall have to deposit the earnest money of Rs. **5,000/- (Rs. Five Thousand only)** in the form of Demand draft/Postal Order payable to **Regional Accounts Officer MPPTCL, Bhopal**. No tender will be accepted without Earnest Money. Please note that Earnest Money deposit in any other form i.e. Bank Guarantee / FDR etc. is not acceptable.
- (6). The tender forms duly filled and completed in all respect should reach the office of **SE 400 KV Sub Station Circle G-1 New Administrative Building Bijli Nagar MPPTCL, Govindpura, Bhopal-462023** on or before the time and due date indicated above.
