Offer completed with all relevant technical details should be submitted in the envelope. The details of enquiry viz. enquiry no. & date, due date etc, must be clearly mentioned on the top right hand side of envelope as well as on offer.
2. The tender forms comprising the detail terms & condition, Schedule I for price bid, Annexure I for scope of works etc. can be obtained from the office of Executive Engineer Testing Division, M.P. Power Transmission Co. Ltd., Itarsi on Payment of cost of Tender Form (i.e. Rs.560/-) through Demand Draft payable to R.A.O. MPPTCL, Bhopal. In case the Tender document is required by

post, an amount of Rs. 150/- is to be paid extra. The date of issue of D.D. shall not be prior to 1 month from the date of issue of tender.

3. The tenderers shall have to deposit the earnest money as per respective tender specification in the form of Bankers Cheque or Demand draft payable to Regional Accounts Officer, MPPTCL Bhopal. No tender will be accepted without Earnest Money. Please note that Earnest Money deposit in any other form i.e. Bank Guarantee/FDR etc. is not acceptable.
4. The tender forms duly filled and completed in all respect should reach the office of EE (T.Dn.), MPPTCL Pathrota Itarsi on or before the time and due date indicated above. The tenders received up to due date and time shall be opened at the date and time specified above, in presence of such tenderers who remain present.
5. The manpower deployed by the agency/contractor should be well conversant with Hindi & English Typing & must have good knowledge of computer basics and English Language.
