02. For any loss and damage of material the contractor shall be sole responsible and MPPTCL shall not bear any responsibility.
03. **Payment :-** 100%payment within reasonable time after completion of aforesaid job work.

The satisfactory completion of the Job work bill in triplicate shall be submitted to the A.E. 132 KV S/s Agar, E.E.(T) Ujjain, who will verify and forwarded the same to the R.A.O. MPPTCL Indore for releasing the payment, after deducting Income - Tax as per rules.

04. The insurance of working personal should be arranged by the contractor.
05. **Penalty :-** In case of delay 0.5 %per week & part thereof subject to maximum of 10% from contractor bill.
06. The Enquiry can be cancelled without any liability.
07. **Enquiry No. and date should be clearly superscribed on envelope.**
08. **GST no. & PAN no. should be mentioned on enquiry/enclosed.**
09. After handingover of the site the area of work will be inspected by the site incharge, if not found satisfactory, the penalty will be imposed @1% per week or part thereof.

Any compensation required to be paid on this ground, if any, shall be born by the contractor.

In case, in unfortunate even if the accident while carrying out unauthorized work, the responsibility for same shall lie on the contractor.
