**QUALIFYING REQUIREMENTS:** (i) The bidder should have Valid 'A' class electrical contractor's license issued by Govt. of M.P.; EPF Code No., GST No. in the name of Firm./Proprietor.

(ii) **Experience Criteria** :- The bidder should have successful experience of construction of at least one No. 132KV bay in EHV substation or 50% value of similar work completed including piecemeal works in the past at same or higher or just below voltage level for the proposed erection work in any EHV Substation.

(iii) **Financial Criteria** :-

(a) **Net Worth** :- Should be positive.

(b) **Minimum Average Annual Turnover of last 3 Financial years** :- 40% of the estimated Cost (Estimated cost Rs. 10.53 Lakhs).

(c) **Working Capital including fund based line of credit of bank** :- Minimum one third of estimated Cost (Estimated cost Rs. 10.53 Lakhs).

(iv) The Company reserved the right to ignore such offers having inadequate financial capacity or large unexecuted past contracts or where unjustified and substantial delay has already occurred in execution of past contract.

(v) While deciding award of contract against any tender apart from the prices quoted and compliance to terms and conditions of the tender specification, MPPTCL, will also take into account such factors as performance against earlier contracts in terms of quality of works done and adherence to prescribed time schedules, Offers of such contractors who have poor record of performance in earlier contracts are liable to be rejected.
