Ltd., Bhopal on payment of cost of Tender Form through Demand Draft payable to **R.A.O., MPPTCL, Bhopal**. In case the Tender document is required by post, an amount of Rs. 150/- is to be paid extra. The date of issue of D.D. shall not be prior to 1 month from the date of issue of tender.
- (2). The Tender enquiry & Tender Document is available on the website of MPPTCL, having web address www.mptransco.nic.in. The Tender Document can be downloaded from the website. If the tender form is downloaded from the website, payment of Rs 560.00 as the cost of the document must be made in the office of Executive Engineer(TDn 1) MPPTCL Bhopal in the form of demand draft/ Banker's cheque in favour of RAO MPPTCL Bhopal payable at Bhopal before submitting the Tender & receipt should be kept in the envelope containing earnest money otherwise it will be liable to be rejected. The work shall be completed with in two months from the date of issue of order.
- (3). The tenderer shall necessarily have past experience of Online partial discharge measurement of CT and other equipments. In absence of above requirements, the tenders shall not be accepted. The tender document may be referred for further details.
- (4). The work place is live and charged area. All labour accidental compensation / insurance charges are to be borne by the contractor. The contractor will be fully responsible for accident and EPF liabilities of labour / staff / persons engaged by him for execution of work.
- (5). Any loss to the Company's property during the execution of work will be your responsibility & you will have to bear any expenditure incurred towards the same.

- (6) No advance payment shall be made for this work.
- (7) The Quantity shown in this NIT is approximate and can be reduced or increased by us as per requirement.
- (8) GST, as applicable, shall be paid extra. For it the tenderer should have GST registration No.
- (9) The tenderer shall have to deposit the earnest money of Rs. 4000/- (Rs. Four Thousand only) in the form of Bankers Cheque or Demand draft payable to Regional Accounts Officer, MPPTCL, Bhopal. No tender will be accepted without Earnest Money. Please note that Earnest Money deposit in any other form i.e. Bank Guarantee / FDR etc. is not acceptable.
- (10) The tender forms duly filled and completed in all respect should reach the office of EE(Tdn1), MPPTCL, Govindpura, Bhopal on or before the time and due date indicated above. The tenders received up to due date and time shall be opened at the date and time specified above, in presence of such tenderers who remain present.
- (11) The quotation should be typed or written in ink only. It should be clear, legible and visible.
- (12) Over writing or cutting on rates and terms and conditions, if any, may result in rejection of quotation.
- (13) This office shall not be responsible for delay on any account, in case of late receipt of tender document.
- (14). The undersigned reserves the right to reject any or all tenders or accept any tender in full or part considered advantageous to MPPTCL whether it is lowest or not without assigning any reason whatsoever.
