
TERMS AND CONDITIONS

3. He must submit the Income Tax return of last three years and having workmen compensation policy for workers.
4. He should experience of working of dismantling dragging / erection in MPPTCL or other similar organisation.
5. He should submit the list of available T&P for above work.

6. L-1 bidder should have to deposit 10% as Security of order value and to execute agreement with the concerned EE (Testing).
7. T&P & other material and labour required for aforesaid work is to be arranged by the contractor at site.
8. For any loss and damage of material, the contractor shall be sole responsible and MPPTCL shall not bear any responsibility.
9. Payment:- As per practice in vogue, the payment shall be released generally within 45 days after completion of the work.
10. The insurance of working personal should be arranged by the contractor.
11. Enquiry No. and date should be clearly mentioned over quotation.
