NOTIFICATION

In accordance with the approval given by GoMP Energy Department vide memo No. F2-14/2012/Thirteen dated 11.09.2013, Human Capital Manual and Wages and Allowances Manual made applicable to employees recruited by the Company, will cease to operate after 31st August 2013.

- 2. The Company is pleased to decide that w.e.f. 1st September 2013, the Wages & Allowances of the employees recruited by the Company shall be governed in accordance with the relevant provisions of erstwhile MPSEB Order No.01-07/WAC/1369 dated 02.03.2009 read with No. 01-07/WAC/4281 dated 13.08.2009 except that the S.Es cadre shall be included in PB-3 with the same Grade Pay of Rs.7600/- and such other provision as adopted/decided by the Company from time to time.

Now, henceforth, services of all the employees recruited by the company shall be governed under rules and regulations as applicable and adopted by the Company for employees finally transferred from erstwhile MPSEB vide Order No. AS/MPPTCL/2929 dated 10.10.2012 and circular no. AS/MPPTCL/1735 dated 25.08.2005 except adoption of M P Civil Services (Pension) Rules 1976. Defined contributory pension scheme (NPS) shall be applicable to all the employees recruited by the Company.
