02. The bidder should be having a valid "A" class Electrical Contractor License. In absence of above requirements, the tenders shall not be accepted.

03. Eligible Bidder:-

Tenderer/ bidder should not be the officer/ employee or relative of MPEB/ MPSEB or its successive company. As per Section-2 [TT] of the Company Act 2013, the definition of relative is as follows: -

A person shall be deemed to be a relative of another if: -

- [a] They are a member of a Hindu undivided family, or
- [b] They are husband and wife, or

[c] The one is related to the other in the manner indicated below:-

Bidders are required to submit an affidavit in this regard in enclosed proforma-1.

04. **Experience Criteria :-** As per the sub-clause No. 1.05.04 Experience criteria under clause No. 1.05 QUALIFYING REQUIREMENT of SECTION-1 of "Tender condition and instruction to bidders" published along with Tender Document.
05. The tenderer should have **Goods & Service tax registration No.** as per provision of GST act, **PAN No., copy of Income Tax return for last three year, certified/audited financial statement, EPF Registration no.** and workmanship Insurance as per the applicability.
06. While deciding award of contract against any tender apart from the prices quoted and compliance to terms and conditions of the tender specifications, MPPTCL will also take into account such factors as performance against earlier contracts in terms of quality of works done and adherence to prescribed time schedules. Offers of such contractors who have poor track record of performance in earlier contracts are liable to be rejected.
07. **EMD Requirement-** The Bidder shall deposit the Earnest Money ₹ 3000.00 through BG/DD/ Bankers Cheque payable at Bhopal which shall be drawn in favour of RAO, MPPTCL, Bhopal. No offer shall be accepted without EMD unless exempted. On opening of enquiry if it is, revealed that EMD amount is inadequate or any other discrepancy is noticed the tender shall be rejected & returned to the bidder. Following categories of bidders are exempted from submission of EMD, provided they submit valid documents along with their bids-
- [a] Registered Small Scale Industries of Madhya Pradesh having permanent registration or MSME registered firms. The registration should be for the items quoted in the tender and should be valid.
 - [b] Ancillary units of Madhya Pradesh State Electricity Board.
 - [c] M.P. State/Central Government undertakings or fully owned State Govt. manufacturing unit with 100% Govt. shares.
 - [d] Small-scale units enlisted with the National Small-scale Industries Corporation for Central Govt. Stores Purchase Program.
08. The tender forms duly filled and completed in all respect should reach to the office of **The Executive Engineer (400KV Testing Division) M.P. Power Transmission Co. Ltd., Bina** on or before the time and due date indicated above. The tender received up to due date and time shall be opened on the date and time specified above, in the presence of such tenderers who remain present.
