- Work Experience** :- Preference shall be given to the contractor who have experience of similar type work in MPPTCL, any state Govt. Organisation/PSU/MPPTCL/PWD or any other Govt. department P.O.
- Full descriptive particulars and drawing of the equipments/work offered should accompany the quotations information regarding the country of manufacture of origin, used the manufacture of the materials should be furnished.
- DELIVERY/WORK COMPLETION PERIOD**:- The ordered material shall be supply within 30 days from date of order. The material shall be supplied on F.O.R. basis to EE Testing MPPTCL Rewa.
- PAYMENT**:- The payment shall be made within 45 days from the date of receipt of material / completion of work and bill in triplicate. The Board/company shall not be liable for any interest.
- SECURITY DEPOSIT**:- S.D. would be deducted as per rule.
- EARNEST MONEY DEPOSIT** :- The Earnest Money **Rs 3085/- (Three Thousand Eighty Five) only** in the form of D.D. in favour of **RAO MPPTCL Jabalpur** paybill at Jablapur shall be deposited with offer. Any offer not accompanied with earnest money shall be liable for rejection.
- ACCEPTANCE**:- It is not binding on the MPPTCL to accept the lowest or any quotation.
- VALIDITY**:- The quotation should remain valid for at least a period of 90 days from the date of issue of the same.
- TAXES** :- The Goods & Service Tax (GST) shall be paybill extra. G.S.T. registration No. of supplier/contractor shall invariably be mentioned on the invoice along with HSN code of item supplied /service rendered.
