

- (1) Other details can be seen in the complete tender documents which shall be made available on e-portal <https://mptenders.gov.in>.
- (2) Tender documents can be purchased only online and downloaded from main portal <http://www.mptenders.gov.in> by making online payment for prescribed non-refundable tender document cost using online Payment Gateway Services integrated in to the e-Procurement System, Services & gateway charges shall be borne by the bidder. Manual purchase of tender is not allowed. It is mandatory for all the bidders to pay tender document cost to participate in the tender.
